

Historical Potice.

During the year 1864, neighborhood prayer meetings were held in the south-western part of this city, by a goodly number of Christians, who had long felt the necessity of working for Christ, and laying the foundations for a truly Congregational Church in this vicinity. These meetings were continued with unabated interest, and a Sabbath School was organized, May 21st, 1865, in a room on the corner of Congress Avenue and Lafayette street, known as Bethesda Hall: the meetings for prayer were also held in this room, and the West Congregational Church * was here organized December 27, 1865, by an Ecclesiastical Council, of which Rev. LEONARD BACON, D. D., was Moderator, and Rev. GURDON W. NOYES, Scribe. Rev. ORLANDO H. WHITE was installed as Pastor, April 16, 1866, by an Ecclesiastical Council, of which Rev. EDWARD E. ATWATER was Moderator, and Rev. GURDON W. Noves, Scribe. After much consultation and prayer in respect to the locating of the house of worship, a lot was unanimously agreed upon and purchased by the Society, in March, 1867, on the corner of

Howard Avenue and Columbus Street, on which the Society' aided by the generous contributions of friends, erected a beautiful stone edifice in 1868. Thus, by the blessing of God, through the unwearied efforts of a faithful Pastor and a united and zealous people, this Church increased from 66 members, at its organization, to its present membership of 305.

Sppointments.

Public Worship, on the Sabbath:

Sabbath School at 10.30 A. M., during the year.

Preaching at 3.15 P. M., during the year.

Prayer meeting in the evening.

The Lord's Supper is celebrated on the first Sabbath in January, March, May, July, September and November.

The Preparatory Lecture is given on the evening of the Friday preceding the Sacrament.

The Missionary Concert of Prayer is held on the evening of each Communion Sabbath.

The Church Prayer Meeting is held on Tuesday evening of each week.

The regular meeting of the Standing Committee, is held on the first Tuesday evening of each month, at the conclusion of the Prayer Meeting. Candidates for admission to the Church, are invited to be present at this meeting.

Children may be presented for Baptism on the last Sabbath afternoon of each month.

Members of the Church and congregation, in sickness or want, are requested to cause their condition to be made known to the Officers of the Church.

The Annual Meeting of the Church is held in the month of January.



Standing Kules.

- 1.—This Church is a free and independent Congregational Church, subject to the government of Jesus Christ, the Great Head of the Church.
- 2.—This Church will extend to other evangelical Churches, and receive from them, that fellowship, advice and assist. ance which the laws of Christ require.
- 3.—The Officers of this Church, in addition to the Pastor, Deacons and Superintendent of Sabbath School, shall consist of a Clerk, Treasurer, and Standing Committee of Three. The Pastor, Deacons, Superintendent and Clerk shall be, ex-officio, members of the Standing Committee. All officers of the Church shall be elected by ballot. Male Members of 18 years of age and upward, only, are authorized to vote in this Church.
- 4.—It shall be the duty of the Deacons to assist in the administration of the Lord's Supper, and to distribute the charities of the Church. At all business meetings, in the absence of the Pastor, the senior Deacon(in service) present shall preside.
- 5.—The Clerk shall keep a record of the proceedings of the Church and Standing Committee, a list of Members, and of Baptized Children; the changes by Death, Removal



or Marriage, and make a report thereof at the Annual Meeting. He shall also report to the Standing Committee, two weeks before the Annual Meeting, the names of such Members as have been absent from the stated services of the Church for one year.

6.—The Treasurer shall be elected from among the Deacons, and shall have the care of all money raised or given for the use of the Church. He shall pay from such money all demands upon the Church authorized by the Church or Standing Committee, and shall advance to the Deacons such sums as they shall require for the expense of the Communion Table, or for the relief of poor members. He shall also receive and disburse all money given for objects of Christian benevolence, and shall render his account to the Church annually of all receipts and disbursements.

7.—The Standing Committee shall receive all applications for admission to the Church, whether by Profession or Letter, and after satisfactory examination, shall recommend them for acceptance; enquire after all public offenses in the Church which may come to their knowledge by complaint or otherwise, and having ascertained the facts in the case, report to the Church both the facts and the measures proper to be taken. The Committee may summon before them any member for examination or brotherly counsel; but in the appointment of this Committee the Members of the Church are not relieved from their obligation to watch over, admonish, and reprove one another. This Committee shall also present an annual plan for benevolent contributions, appoint collectors, ascertain the wants of poor mem-



bers, and when necessary, make appropriations for their relief and attend to all matters referred to them by the Church.

- 8.—There shall be appointed at each annual meeting, a Committee of Three, whose duty it shall be to report at the next annual meeting an account of the state and progress of religion in the Church during the year.
- 9.—No persons shall be admitted as members of this Church on a Profession of Religion, until they have been examined by the Standing Committee, and on such examination are believed to be sincere followers of Christ, nor until they have been propounded for at least two weeks, and accepted by vote of the Church. All persons wishing to unite with this Church from another Church, shall exhibit their Letters of dismission from the Church with which they have been connected, with suitable testimonials of Christian character, and also they shall publicly enter into Covenant when practicable with this Church. Testimonials in such cases are to be read to the Committee at least one week before the vote of admission is taken.
- 10.—All members of this Church removing to another place, are expected to ask a dismission and recommendation to some Christian Church at the place of their residence, within one year after their removal. Requests for such Letters may be made at any stated meeting of the Church, and if at the end of one week no objection has been made, the Pastor or Clerk shall issue the customary certificate. Any person neglecting to ask for a dismission as



aforesaid, may be admonished by the Pastor and Clerk in such a manner as may be deemed expedient.

11.—It is expected that members of other Churches who may wish to commune with this Church for more than one year, will request Letters of dismission from their respective Churches, and admission to this, unless they assign reasons for delay satisfactory to the Standing Committee.

12.—The directions given in Matt. xviii, 15-17, shall be observed in regard to private offenses. Public and notori ous offenses must be referred to the Standing Committee. All members who absent themselves from the appointed services of the Church without presenting satisfactory reasons therefor, shall be amenable to discipline.

13.—Communion Services shall be held on the first Sabbath of each alternate month, commencing with January.

14.—The Sabbath School shall be under the direction and care of the Church. Its rules shall be approved, and its Superintendent and two assistant Superintendents elected by the Church. The officers of the School shall be a Superintendent and two assistant Superintendents, a Secretary, Treasurer, Librarian and assistants, who shall be elected annually. The Superintendent and assistant Superintendents shall constitute a Board of Managers, and shall nominate the other officers of the School, who shall be elected by the Teachers.

15.—All business meetings of the Church shall be opened with prayer. An annual meeting shall be held in the month of January, of which notice shall be given from the pulpit on the preceding Sabbath. At this meeting the



records of the last year shall be read, the catalogue of members revised, and accounts presented by the Treasurer of all money received and expended, officers elected for the ensuing year, and the reports of the Superintendent of Sabbath School and the Committee on state and progress of the Church, shall be presented; also, any other business proper to be transacted at such meetings. Special meetings shall be called at any time by the Pastor, the Standing Committee, or by the Clerk—at the request of seven male members of lawful age; but in the last case, notice must be given from the pulpit as in the call of the annual meeting. In all meetings for business, the Church shall be governed by the usual rules of order for deliberative bodies.

16.—The Articles of Faith and Covenant shall be read from the pulpit the first Sabbath of each year.

17.—The Articles of Faith, Covenant, Form of Admission, or Standing Rules, must not be altered except by a vote of two-thirds of the male members of lawful age at an annual meeting, or at a meeting called for the specific purpose, the proposed alteration having been submitted in writing at least two weeks previous to the meeting. Any of the Standing Rules may be suspended on a special occasion by a vote of two-thirds of those present at a regular meeting.



Exticles of Faith.

ARTICLE I.

We believe there is one only living and true God, the Father, the Son and the Holy Ghost, Eternal and Infinite in all His attributes, self-existent, and unchangeable; one in essence; one in will; and to be adored as the Creator and the Moral Governor of the Universe.

ARTICLE II.

We believe that the Scriptures of the Old and New Testament were given by the Inspiration of God, and are the only perfect rule of Faith and Practice.

ARTICLE III.

We believe that all mankind are by nature sinful, destitute of holiness, and that all who sin and repent not, are justly exposed to the penalty of the Divine Law.

ARTICLE IV.

We believe that the only Redeemer of men is the Lord Jesus Christ, who is very God and very Man, who died, the just for the unjust, rose again, ascended on high to make intercession for us and to bring His Beloved to Glory and Immortality in Heaven.



ARTICLE V.

We believe that the regeneration by the Holy Spirit is indispensable to Salvation, and that all who are thus regenerate are kept by the power of God, through repentance and faith unto Salvation.

ARTICLE VI.

We believe that the Salvation of the Saints, is by no merit or wisdom of their own, but by the full, free, unmerited Grace of God, which work of Grace is begun, carried on and completed by the Holy Spirit.

ARTICLE VII.

We believe that there will be a Resurrection of all the dead, and a day of general Judgment; whereby God will vindicate His Moral Government, correct the wrong decisions of men, receive the righteous in their glorified bodies unto eternal life, and consign the wicked to punishment eternal.

ARTICLE VIII.

We believe that the Sacraments of the Christian Church are Baptism for Believers and their Children, and the Lord's Supper for the visible members of Christ's Church.

ARTICLE IX.

We believe in the sacred observance of the Lord's day for rest, worship and religious instruction.



ARTICLE X.

Finally, we believe it is our duty to carry the Gospel, according to our ability, to the people of every nation, and to teach all men the things which Christ has commanded us to observe and do.

Form of Somission.

Having considered the Articles of Faith adopted by this Church, you cordially accept them for substance, as Divine truth, and declare your belief in the Father, the Son and the Holy Spirit, one God, maker of heaven and earth; in the Scriptures of the Old and New Testaments as His inspired Word; in the state of man, as sinful and lost without the atoning sacrifice of the Lord Jesus Christ, who died on the cross, rose again, ascended on high, and ever liveth to make intercession for us; in the necessity of renewal and sanctification by the Holy Spirit, in a future resurrection and a final judgment.

This belief, you now publicly affirm.



Che Cobenant.

You do now solemnly, in the presence of God, His holy Angels and this assembly, with sincere contrition for all your sins, humbly avouch the Lord Jehovah to be your God and portion forever. You do cordially acknowledge and receive the Lord Jesus Chirst as your Prophet, Priest and King, your Omnipotent Savior and Judge; and the Holy Spirit as your Sanctifier, Comforter and Guide. You consecrate yourself and all your powers to the service and glory of God, and promise through the assistance and grace of His Spirit you will make Him your chief good-that you will give diligent attention to His word and ordinances, and labor to keep all His holy commands—that you will seek the honor of His name and the interests of His kingdom, and that henceforth, forsaking every known sin, you will make it your constant care to live soberly, righteously, and godly in the world. You promise to submit to the laws of His kingdom as defined by the Manual of this Church, and with us strive for its gospel peace, edification and purity, and to walk with its members in all Christian love, faith. fulness, circumspection, meekness and sobriety.

This you solemnly covenant and engage.

The Church will rise to Covenant with these.



We, then, the Church of our Saivor here assembled, in view of your engagements, do receive you into our sacred fellowship, promising to watch over you with Christian affection and care, ever treating you in love as a member of the body of Christ, who is Head over all things to His Church.

This we do, imploring of our Lord that both we and you may obtain mercy to be faithful in all our covenant obligations, that we may glorify Him with the Holiness which becomes His Church forever.

And now, the God of Peace that brought again from the dead our Lord Jesus, that great Shepherd of the sheep, through the blood of the everlasting Covenant, make you perfect in every good work, to do his will, working in you that which is well pleasing in his sight, through Jesus Christ, to whom be glory forever and ever. Amen.
