Terms of Office.

The city officers will hold for two years. The aldermen in the first and third wards will hold office for two years. The councilman in each of the four wards receiving the highest number of votes will also hold office for two years.

THE NEW CITY OFFICIALS.

Mayor-Elect Hopkins.

Lewis LeGrand Hopkins will assume the title of first mayor of the city of Danbury, being elected by a majority of 322, his principal opponent, Mr. Wildman, republican opponent, Mr. Wildman, Mr. Hopkins was born in New Fairfield February 24, 1842, and is therefore forty-seven years of age. When eleven years of age he lost his father and worked for a farmer in New Fairfield for his board and clothing. He afterwards worked as a newsboy on New Jersey railroads and also on the Consolidated road. At sixteen he went to sea, going aboard as a common deck hand, and when off the Welch coast his ship was burned to the water's edge, he suffering a fracture of the skull for which he was successfully treated at a hospital in Liverpool. He next turned up in the California gold fields, returning by way of Cape Horn. In 1865 he married and engaged in business in Danbury and New Fairfield, he being town clerk in the latter place for twelve years. In 1870, '71, '75 and '81 he represented New Fairfield in the lower branch of the general assembly, and in 1887 he represented Danbury in the same house. Up to one year ago he was freight agent on the Danbury and Norwalk railway, which place he resigned to accept the wardenship. Mr. Hopkins has been assessor, member of the board of relief, justice of the peace, school committee-man, and for several years a member of the Democratic state central committee for this district. He is identified with many of the local societies.

Eugene H. Perrett.

Mr. Perrett, the newly-elected city clerk, is a native of France. He came to Danbury about twenty years ago. For nine years he was bookkeeper for W. Beckner & Co., the hat manufacturers. For the past year he has been a member of the firm of C. M. Horch & Co. One year ago he was elected clerk of the borough, and has just closed a term of efficient, valuable service.

James Doran.

James Doran, the successful candidate for the office of treasurer, is one of the oldest business men of the city. Since 1869 he has been identified with the firm of Doran Bros., grocers. Mr. Doran is a native of Ireland, born in that country in 1844. He moved to America at the age of ten years, living in Danbury continuously since that time. He has not been an aspirant to office, and his present election was not due to efforts of his office. He has twice been elected to the office of justice of the peace, but has never officiated in that capacity.

E. M. Bulkley.

The Auditor-Elect Eugene M. Bulkley, is well known among our business men, having been connected with various firms in the capacity of bookkeeper during his fifteen years' residence in Danbury. Mr. Bulkley was born in Weston, in 1851, moving to Danbury in 1874. He has been elected auditor of the town three times, and has held a similar position under the borough government. He is a prominent member of St. James' church, having held the office of treasurer seven years, and is now a vestryman.

William H. Lynch, the first city sheriff, is a well known hatter, a finisher by trade. He is a native of Danbury, having been born here in 1853. He has resided here continuously with the exception of a few years spent at school in Niagara. He has twice been elected constable.

First Ward.

Charles S. Peck, who will represent the first ward in the aldermanic chamber, is well known as a local manufacturer, being a member of the Danbury Machine company. Mr. Peck was born in Yonkers, N. Y., in 1853. He came to Danbury in 1872, and was for twelve years associated with R. A. Belden & Co., machinists. He has been connected with his present firm six years. He has never held public office in Danbury.

Matthew W. Scott, councilman of this ward, is a well-known hatter for many years in the employ of the Tweedy Manufacturing company, and more recently of the firm of Scott Bros., hat manufacturers. He was born in Liverpool in 1849. He has acted as a burgess, and has been chief of the fire department, of which he is a well-known member.

Henry W. Hoyt, councilman of the first ward, is well known in Danbury, having been born here and lived here all his life. He has been in the employ of Hull & Rogers as bookkeeper twelve years, and is a member of the real estate firm of Hull, Rogers & Hoyt. He has never before been elected to any public office.

Second Ward.

G. Mortimer Rundle, the alderman of the Second ward is one of the best known hat manufacturers in Danbury, being a member of the firm of Rundle & White. Mr. Rundle is a native of Southeast, N. Y., but has lived in Danbury since a boy. He has never before held office.

Caleb M. Purdy, councilman, is a well known grocer, having a place of business on Highland avenue. He was born in Dutchess county, N. Y., in 1848, moving to Danbury in 1873. He worked at his trade as a carpenter until he started his present business. He has never before held office.

Charles L. Halstead, councilman of the Second ward, is a well known druggist. Mr. Halstead has been engaged in business in Danbury sixteen years. He is a native of Newburgh, N. Y., where he was born in 1847. He has held the office of burgess.

Third Ward.

Alderman F. Oliver Smith, of the Third ward, is a native of Ridgefield, having been born in that village in 1840. He came to Danbury in 1862, and has since been engaged in the lumber business principally. He is now a member of the firm of Selbeck & Smith, successors to D. & J. Stevens, manufacturers of sash, blinds and mouldings. He has held the position of town clerk one year.

Oscar H. Meeker, one of the Third ward's successful candidates for councilman, was born in Bridgeport in 1848. He came to Danbury in 1883, and has since successfully carried on the feed and grain business on Canal street. He has held no previous office in Danbury.

George W. Taylor, councilman of the Second ward, is a dealer in leaf tobacco, and has lived in Danbury six years. He was born in Newtown in 1841. He is a hatter by trade and worked in Bethel nearly twenty years. He has not been before elected to public office in Danbury.

Fourth Ward.

James E. Walsh, the successful candidate for the aldermanship of the Fourth ward, is a prominent member of the bar and well known in politics, both local and in state matters. He has acted as chairman of the Democratic town committee five years, and has been a member of the state central committee two years. Mr. Walsh is a native of Pittsfield, Mass., and has lived in Danbury nine years. He has never before aspired to public office.

Dietrich E. Loewe will represent the Fourth ward the coming term in the lower board of the common council. He is identified with the business interests of Danbury, and has had some experience in legislation. Mr. Loewe was born in Germany, June 21st, 1852. When fourteen years old he left the common school to enter the Academy of Industry and Trade, at Breilfeld, Germany. He is the senior member of the firm of D. E. Loewe & Co., hatters, whose factory is on River street. In 1884 and 1886 he was assessor, and in 1880 was assistant chief of the fire department. In 1887 he represented Danbury in the state legislature.

William McPhelemy, who will represent the Fourth ward in the new council chamber, was born in Danbury in 1861, and is the youngest member of the in-coming board. After going through the lower district school he entered the Danbury High school, but left before graduating to enter Eastman's college in Poughkeepsie, N. Y., where he graduated in 1879. Since his graduation he has been bookkeeper for his uncle. He is also identified with the hat firm of C. M. Horch & Co. Last year he was a member of the High school committee, being elected clerk of that committee. He will be twenty-eight years old next November.
