

THE RECORD OF TEN YEARS.

THE UNION CONGREGATIONAL CHURCH OF CHRIST of Rockville, Conn., was organized August 7, 1888, when 411 members of the First and Second churches presented letters to the new organization in which they had voted to unite. Tracing their history back, we find that the Second Church was formed February 22, 1849, with 48 members, 29 from the First Church and 19 from other churches. The First Church was organized October 26, 1837, with 40 members, 35 of them from the church at Vernon Centre. This church was an off-shoot, organized in 1760, of the church in Bolton, of which Vernon was then a part; the Bolton church from which all this family of churches sprang, was formed in 1725.

On April 3, 1888, the building of the Second Church was destroyed by fire. About the same time the town of Vernon wished to acquire the site of the First Church building for a Memorial Town Hall. As there were eight churches in the village (Rockville became a city a year later, in April, 1889), the way seemed to be providentially opened for the union of the Congregationalists into one body, and after mature and prayerful consideration of the matter, and a thorough canvass of the two churches and congregations, union was decided on.

The Union Ecclesiastical Society was formed on

June 15, 1888, and into its hands the property of the societies connected with the First and Second churches was duly conveyed. The Union Church was organized by 189 members of the First and 222 of the Second Church; and on the same day a council of churches welcomed the new church into the Congregational fellowship.

The building of the First Church was moved to the south side of Main street,—the lot having been sold to the town,—and used for services of worship until the new building was ready to be occupied. Rev. Charles H. Ricketts, the last pastor of the First Church, acted as pastor of the Union Church until May, 1889. On December 12 of that year, Rev. James Dingwell was installed by council as first pastor of the new church.

After considering other locations, the Ecclesiastical Society voted on July 24, 1888, to build a new church building on the site of the former Second Church. Plans submitted by Mr. Warren H. Hayes of Minneapolis were accepted, and on the anniversary of the burning of the Second Church the contract for the erection of the present beautiful stone edifice was signed. September 5, 1890, the Building Committee, consisting of J. G. Bailey, George Sykes, Crosley Fitton, George M. Paulk and Dr. E. K. Leonard, presented the finished building to the Society, reporting its total cost to date as \$74,586.90. The church was first opened to the public for an organ recital by Mr. W. C. Hammond on the evening of September 17. The services of dedication were held the next day. The sermon was by Rev. E. A. Reed, D. D., of Holyoke, Mass.

The work of the Union Church was well organized from the first. The officers of the Sundayschools connected with the former churches served until the New Year, when the new Sunday-school was organized. The Endeavor Society was organized September 4, 1888. Other organizations soon followed,-the Ladies' Aid Society, the Woman's Missionary Society, the circles of King's Daughters, the Children's Missionary Society. A most important step was taken when the Board of Deaconesses and Visitors was organized. Only by their aid has it been possible for one pastor to do the work of a parish that for forty years had been accustomed to the services of two. Our organizations are the tools with which the church works; sometimes they have to be repaired a little, but we waste no time trying to patch up a worn out machine; when one organization is no longer effective in its work, we cast it off and form another.

For ten years now the Union Church has been doing its work in a quiet, systematic way. It has made a record of patient service and effective work that can be told only in small part by the reports here printed. Its first four years were prosperous ones for the city, but with the panic of 1893 began the business depression which has continued with but little intermission until the present time, seriously affecting both city and church. Our losses by death and removal have been not only numerous, but of the kind that can never be made good. Few have come to take the places of those who have gone from us; but new workers have developed rapidly on the field under the demands made upon them, and the work has been maintained and even done with increasing efficiency.

Some of the names of those whose loss was a serious blow to the church should be recorded here. To the larger fellowship above, the Master called, on April 2, 1891, Deacon George Maxwell, who had been the most prominent citizen of the town for many years, and for thirty-five years was deacon in the Second and Union churches; on March 1, 1893, John N. Stickney, for forty-four years deacon in the First and Union churches. Others who have passed into the better life are E. C. Chapman, S. G. Risley, Elijah Holt, G. N. Brigham, Dr. F. L. Dickinson and A. D. Harwood. Of the many removals, mention can be made here of only Judge Dwight Loomis and Deacons A. E. Richardson and G. M. Pease.

An event of great importance was the reception in February, 1892, of the legacy of \$5,000 left by Mr. Maxwell for the maintenance of a free readingroom in connection with the church. The Ecclesiastical Society appointed five trustees to have charge of the fund, and set apart rooms for this purpose. The rooms were furnished by the Maxwell family, and opened to the public in the spring of 1892. From that time they have been increasingly useful, the average daily attendance steadily rising to above 80 per day. In 1898 the heirs of Mr. Maxwell raised the amount of the endowment to \$10,000.

By the will of Deacon Stickney, \$1,000 came into the hands of the treasurer of the church as a permanent fund for the charitable work of the church. It is kept on deposit in the Savings Bank of Rockville, and the interest is used by the deaconesses in their ministry to the poor. Smaller legacies, but significant ones, were the \$100 left by Mrs. Henrietta Bodfish in 1891, and the \$100 by Mrs. Harriet J. Thompson in 1893, for a permanent fund for the Bible School Library.

For about a year the church was without a pastor. Mr. Dingwell was dismissed September 5, 1895, and the present pastor was installed September 16, 1896. Among the features of our work since that date are the annual roll-call meetings of the church at the close of each year, the adoption of the constitution for the Bible School, of the custom of presenting Bibles to the baptized children of the church on their attainment of the age of ten, of the form for admission of members to the church prepared by the committee of the National Council, the plan of holding Workers' Conferences and a special Week of Prayer in the autumn, and special Holy Week services before Easter. The custom of devoting the benevolent offerings of the month of November to Thanksgiving charities and those of December to the Christmas festivities of the Bible School, has been followed with increasing satisfaction.

The Sunday Evening Service was a problem for several years; it became an experiment when the plan of holding a service of worship with a sermon at 6:30 P. M. was adopted, and now that the Men's Union has given the service a special function and meaning, it seems to have passed from the stage of experiment to that of success. Another important step in 1898 was the adoption of the plan of "Advanced Endeavor." We had no Endeavorers who were willing to be graduated, but several who had already in fact advanced to important positions in the work of the church. Our plan, which, as will be seen by the Constitution further on, has some marked advantages, is working well, and promoting the effectiveness of our society, already the largest in the state.

The Bible School, while showing some falling off in numbers, is in better condition than ever, for the work of past years toward a graded school has brought forth splendid results. Though the growth of the city and also that of the church has been hindered by the five lean years just past, there is every reason to feel encouraged at the present outlook; and it is with pleasure that we note that the membership of the church, after declining almost steadily from 1891, shows a marked increase in 1898.

Figures cannot tell the story of our ten years' work. It is written in hearts and lives, in souls redeemed and spirits exalted with assurance of eternal life. Yet figures are not without their interest, and the tables on the following pages will suggest more than could be fully told in many pages




NOTES ON THE TABLES.-In Tables II and III, cents are omitted and the amounts given are the nearest in dollars.

In Table II it has been found impossible to tell exactly what amounts are counted twice. The following are known: \$432 from the Y. P. S. C. E. to the church treasurer for benevolence; \$1741 from the church treasurer of the Bible school; \$795 from the church treasurer of the Ecclesiastical Society (box collections); \$2795 from the church to the Bible school; \$981 from the Ladies' Aid Society to the treasurer of the Ecclesiastical Society (box collections); \$2795 from the church to the Bible school; \$981 from the Ladies' Aid Society to the treasurer of the Ecclesiastical Society (box collections); \$2795 from the church to the Bible school; \$981 from the Ladies' Aid Society to the treasurer of the Ecclesiastical Society for the debt; a total of \$10,336, which deducted from the sum of the last column gives \$191,918 as the total amount raised up to January 1, 1899. To this should be added the receipts of the Ecclesiastical Society for the year ending March 30, 1899, as follows: Pew rents, \$4,129; Church collections, \$823; Maxwell Fund, \$733; Other, \$544. Total, \$56,329. Also the receipts of the Men's Union to March, 1899, \$516, making the granul total of all receipts reported to April 1, 1899, \$733.

It is known that this sum does not include all; the reports of some of the organizations are not complete. The tables are as nearly correct as they can now be made.

ORGANIZATION AND DEPARTMENTS.

The Ecclesiastical Society. CONSTITUTION.

Adopted June 15, 1888.

WHEREAS, on the morning of April 3, 1888, the Second Congregational church edifice was totally destroyed by fire, and

WHEREAS, the land upon which stands the First Congregational church edifice and chapel, has been sold and conveyed to the Town of Vernon as a site for the proposed Memorial Hall, thus rendering both Ecclesiastical societies practically without worship, and

WHEREAS, the two Congregational churches, and Ecclesiastical societies connected therewith have voted with a good degree of unanimity that the time has come when these two churches and societies should be united into one church organization of our order, and one society, therefore

Resolved, 1st, that we "do hereby unite to form a religious society by voluntary association for public religious worship,"* which society shall be known as the Union Ecclesiastical society of Rockville, Conn., and be governed by such rules and by-laws as the

society may adopt which shall be in harmony with the statutes of the State of Connecticut.

2d. The constitution and articles of faith which may be adopted by the church to be organized, shall agree with the constitution and articles of faith held by the Congregational churches of Connecticut, and no minister shall be settled as pastor over said church and society, whose belief and practice does not accord therewith.

3d. The pulpit, in the absence of the settled pastor, shall be under the care of a committee of supply to be chosen by the church, provided that in the settlement of a pastor, the church and society shall act together.

4th. The officers of the society shall be a clerk, a treasurer, and a committee of not less than three persons, to be chosen by ballot, all of whom shall perform the duties which ordinarily devolve upon such officers.

5th. The time to which the first board of officers shall be elected, shall expire on the last Friday in March, 1889.

6th. The annual meeting of the society shall be held on the last Friday in March in each and every year.

7th. All persons now members of the First and Second Ecclesiastical societies may become members of this society, by signifying in writing their desire to become members thereof.

8th. From and after the adoption of this constitution, any person who is not a member of the First or Second Ecclesiastical societies, desiring to become a member of this society, shall "lodge with its

clerk" or some other officer thereof, "a written declaration of his desire to become a member of it," at least one month before being acted upon, and "thereupon such person shall become a member unless a majority shall at such meeting manifest their dissent thereto."*

9th. Any alteration or addition to these articles shall be proposed in writing at a previous meeting to being acted upon and may be adopted by a majority of the members present.

The Ecclesiastical Society owns the church building, corner of Union and Elm Streets, and the parsonage at No. 62 Union Street. This property is valued at \$82,000. The Society also holds, by its trustees appointed for this duty, the George Maxwell Fund of \$10,000, the interest of which is used to maintain the Reading Rooms.



The Church.

CONSTITUTION AND CREED.

I.-NAME.

This church shall be called the UNION CONGREGA-TIONAL CHURCH OF CHRIST, in Rockville, Conn. The government shall exist in membership alone.

II.—Officers.

I. The officers of this church shall be a Pastor, not less than six Deacons and a Clerk and Treasurer.

2. These officers shall be chosen by ballot, a majority of members present electing.

3. The pastor may be a member of this church, and shall have control of the pulpit, administer the ordinances, be, *ex-officio*, moderator of business meetings, and exercise general spiritual supervision over the church.

4. The deacons shall be elected for three years, the term of one third of the number expiring each year. They shall aid the pastor in the celebration of the ordinances, shall have the oversight of the poor, and shall assist the pastor generally in the spiritual care of the congregation. They shall together exercise all the duties also of a Prudential and Examining Committee, and in the absence of a pastor they shall have charge of supplying the pulpit.

5. One person may fill the offices of Clerk and Treasurer, and shall be chosen annually. It shall be the duty of the Clerk to record the doings of all business meetings, to keep a register of the members, date of their admission, dismission or death, and a record of all baptisms. He shall issue such letters of dismission as shall be voted by the church, keep on file all valuable papers, and shall make a report at each annual meeting of the business transacted, and of such events and Christian work as shall indicate the progress of the church.

6. The Treasurer shall have charge of the church funds, which shall be used for the ordinary church expenses, and at the discretion of the Pastor and Deacons, for the relief of any needy members.

III.—MEMBERSHIP.

1. Admission.—(a.) The examination of candidates for admission to this church shall be conducted by the Pastor and Deacons, and be open to all members of the church. If exhibiting satisfactory evidence of piety, and assenting to the Faith and Covenant of the church, they shall be propounded at least one week previous to their reception, and then, if approved by the church, shall be received on public profession of their faith in Christ and on entering into covenant with the church.

(b.) Members of other churches applying for admission by letter, may be received by vote of the church and by entering into covenant with it, the letter recommending them being read at least a week previous to their reception.

2. Members of this church removing to another place will be expected to take letters to the church where they shall reside, as soon as convenient.

3. Discipline. Any member of this church shall

be liable to discipline who holds unscriptural religious views or is guilty of conduct condemned by the Scriptures, or who shall habitually neglect the ordinances of the church for the space of a year without valid reasons. Cases of discipline shall be conducted according to the method laid down by our Lord in Matt. 18: 15-17.

IV.—MEETINGS AND CONTRIBUTIONS.

1. The annual meeting of this church shall be held on any day or evening in the month of December, of which notice shall be given from the pulpit on the preceding Sunday, when the annual reports shall be rendered and the regular elections held.

2. Special meetings may be called by the officers of the church, or at the request of any five members, by notice from the pulpit on the preceding Sunday. Delegates to Councils or Conferences may be appointed at any regular meeting of the church.

3. Contributions shall be solicited in the congregation for the leading objects of Christian beneficence, according to a schedule adopted by the church, and in such a manner as the church shall decide.

V.—ORDINANCES.

The Lord's Supper shall ordinarily be celebrated on the first Sabbaths of January, March, May, July, September and November. It shall be preceded by a special preparatory service. The invitation to the Lord's table shall be such as to include all who love our Lord Jesus Christ in sincerity, and who have made a public profession of their faith.

VI.—Amendments and By-laws.

1. This Constitution, the Confession of Faith, and the Covenant, may be altered at a meeting of which due notice shall be given on the preceding Sabbath, with a statement of the proposed alteration, by a majority of the resident members of the church, or by two thirds of those present, provided the change does not infringe upon the doctrines or organic principles of this church.

2. By-laws, to carry out the provisions of this Constitution, may be enacted at any business meeting of the church.

THE CREED.

ARTICLE I. We believe that there is one only living and true God, existing from eternity; that He is a spirit, and infinite in all possible perfections; that all things were made by Him, and that He worketh all things after the counsel of His own will.

ART. II. We believe that the Scriptures of the Old and New Testaments were written by holy men, as they were moved by the Holy Ghost, and contain the only perfect rule of faith and practice.

ART. III. We believe that God exists in three : persons, the Father, the Son and the Holy Ghost, who are one in essence, and equal in every divine | perfection.

ART. IV. We believe that man was created perfect in holiness, but that he fell from his original state of rectitude by sinning against God, and that in consequence of his apostacy, sin and misery have been introduced into the world, and that all men, unless renewed by the Holy Ghost, are destitute of holiness and under the curse of the divine law.

ART. V. We believe that the Lord Jesus Christ assumed the nature of man, and by His sufferings and death on the cross, made atonement for the sins of the world.

ART. VI. We believe that eternal life is offered to all through the atonement which has been made for the sins of the world; but that such is the state of the natural heart, that none will accept of the offer by the exercise of true repentance for sin and faith in Christ, without the special influence of the Holy Spirit.

ART. VII. We believe that all who are made partakers of renewing and sanctifying grace, will be kept by the power of God, through faith unto salvation.

ART. VIII. We believe that we are under obligation to obey all the commands of God, and that the faith which is justifying will produce good works.

ART. IX. We believe the first day of the week should be observed as the Holy Sabbath; that the worship of God in the closet, family and sanctuary, is divinely appointed. We believe that it is a Christian duty to contribute for the support of the Gospel at home, and for the diffusion of its blessings through the earth.

ART. X. We believe that any number of Christians duly organized, constitute a church of Christ, and that He hath appointed ordinances for worship and discipline; that the Sacraments of the New Testament are Baptism and the Lord's Supper, and are to be administered to visible saints, and that the children of believing parents are to be baptized. ART. XI. We believe in a state of future rewards and punishment; in the resurrection of the dead; that God hath appointed a day in which He will judge the world in righteousness by Jesus Christ; that He will sentence the wicked to everlasting punishment and receive the righteous into life eternal.

RESOLUTIONS.*

Adopted by the church, December 9, 1897.

WHEREAS, The New Testament requirements for membership in the Church of Christ are repentance for sin and faith in the Lord Jesus Christ; and

WHEREAS, The Creed and Covenant of this Church have seemed in the minds of some to impose other requirements upon the members; therefore be it

Resolved, first, That all who exhibit penitence for sin and faith in our Lord Jesus Christ are welcome to our fellowship;

Resolved, secondly, That the members of this church regard themselves as disciples, learners, looking to the church for both instruction in the truth and guidance in conduct;

Resolved, thirdly, That those who are called to teach in the church are expected to teach the unchanging truth of the everlasting gospel of Christ, as set forth in the Holy Scriptures and formulated in the Creed of this church;

Resolved, fourthly, That hereafter in the reception of members into this church the form of admission recommended by the committee of the National Council in 1894 be used.

FORM OF ADMISSION.

Those who are to be received being arranged in convenient order for the service, the minister will say:

Dearly beloved, called of God to be his children through Jesus Christ, we give hearty thanks to God, who, by his Spirit, has opened your eyes to see, and your hearts to receive Jesus as Lord, and who has inclined you to present yourselves at this time to make confession of Him.

With us and with the church throughout the world you confess the common faith, saying:

I believe in God the FATHER Almighty, maker of heaven and earth; and in JESUS CHRIST, His only Son, our Lord; who was conceived by the Holv GHOST, born of the Virgin Mary; suffered under Pontius Pilate, was crucified, dead and buried; the third day He rose from the dead; He ascended into heaven and sitteth at the right hand of God the Father Almighty; from thence He shall come to judge the quick and the dead. I believe in the Holv GHOST; the holy catholic Church; the communion of saints; the forgiveness of sin; the resurrection of the body, and the life everlasting. Amen.

Thus confessing with us and with all saints your Christian faith, before the Lord Jesus, and in the presence of His people, you devote yourselves to the love, obedience and service of Jesus Christ; to walk in all His ways now known, or hereafter to be madeknown to you, whatever it may cost you, according to your best endeavor, the Lord assisting you.

Response, I do.

The minister, addressing those baptized in childhood, may say:

You who are children of the covenant do accept for yourselves the seal of baptism into the name of the Father and of the Son and of the Holy Ghost, to which faith and love brought you in childhood.

Response, I do.

Addressing those who are to be baptized, the minister may say:

You who now enter into the everlasting covenant of grace do humby yield yourselves to baptism, as the token of the new life wrought in you by the Holy Spirit, and as the sign of your purpose to be forever the Lord's.

Response, I do.

Then should baptism be administered to those who have not been baptized.

The baptism shall be with these words: I baptize thee, N, into the name of the Father and of the Son, and of the Holy Ghost. Amen.

Then should those who have letters from other churches come forward, as by previous arrangement, or rise.

The minister may greet these, saying: Beloved in the Lord, we bid you welcome who come to renew the vows before made when elsewhere you declared your faith in Christ. We greet you as kinsmen in Him, as fellow-laborers in His service and fellow-travelers to His promised rest.

The minister, addressing all who are to enter into fellowship with the church, will say:

Beloved in the Lord, you have all been baptized into the name of the Father and of the Son and of the Holy Ghost, have confessed the faith of Christ before witnesses and have given yourselves to God in an everlasting covenant of grace. You do now cordially unite yourselves with this church of Christ: to share with us in its worship and work; to walk with us in love and faithfulness, so long as your relation to us shall continue.

Response, I do.

The members of the church will rise and the minister will say—

We, then, the members of this church, receive you into our communion and welcome you with joy to our fellowship.

We promise to pray for you, to watch over you and help you so long as you shall continue with us. God grant, that loving and being loved, serving and being served, blessing and being blessed, we may be prepared while we dwell together on earth for the perfect fellowship of the saints above. Amen.

Here the minister may give to each the hand of fellowship, with some appropriate passage of Scripture, in this or like manner:

In token of our welcome receive the hand of fellowship, and remember the word of Scripture which saith, "Ye are my friends, if ye do whatsoever I command you."

DEARLY BELOVED :- Believing that the promises of God extend to the children of the faithful, and that He has already shown His good will toward these children by giving them not only life and innocence, but also a Christian inheritance and birthright, you bring them to receive baptism as the seal of God's grace, marking them as His little ones. You recognize God's claim on these children, and here devote them to His service. You promise to bring them up in the nurture and admonition of the Lord, and to do all that in you lies to bring them to the knowledge and faith of their Saviour Christ. You engage to teach them the Word of God, to pray for and with them, and to fashion your own lives, as far as you are able, by the rule and teaching of Christ, that you may be wholesome examples to vour children.

Do you, seeking and trusting the aid of the Heavenly Father in your parental duties, thus engage and promise?

Answer: We do.

Baptism. Prayer. On January 14, 1897, the church voted to adopt the custom of presenting a Bible to each one of the baptized children of the church on the attainment of the age of ten years. In accordance with this vote, Bibles have been presented to 144 children.

a general information committee to keep the pastor and other officers acquainted with all cases of special need, and are entrusted with oversight of the charitable work of the church. The Board of Deaconesses meets regularly on the first Friday of each month at three o'clock, in the south parlor.

The Bible School.

CONSTITUTION.

ART. I.-NAME.

This organization shall be called the Union Congregational Bible School of Rockville, Conn.

ART. II.—OBJECT.

The object of this Bible School shall be to study and teach the Holy Scriptures, for the purpose of leading all who are connected with it to an intelligent Christian faith and life.

ART. III.—MEMBERSHIP.

All persons who express the purpose of attending regularly may be enrolled as members of this school. Officers, teachers and adult members shall alone be entitled to vote, except in the appropriation of contributions for benevolent purposes, in which case all contributors may vote.

ART. IV.—OFFICERS.

The officers shall consist of Pastor, Superintendent, Assistant Superintendents, Department Superintendents, Secretary, Treasurer, Librarian, and an Executive Committee which shall consist of the aforenamed officers and three other members appointed by the church. These officers shall hold office for one year, and shall be nominated by the voting members of the school, and elected by the church, except the Pastor, who as Pastor of the church shall also be pastor of the school. Other assistants shall be provided as the needs of the school may require, appointed as the other officers, or by the Executive Committee.

ARTICLE V. - COMMITTEES.

(a) There shall be a permanent Library Committee, consisting of three members, one of whom shall be appointed each year to serve for three years. The duties of this committee shall be to take full charge of all matters relating to the library. They shall have power to purchase such books and supplies, subject to approval of the Executive Committee, as shall from time to time be necessary, and shall make such recommendations to the school as shall in their judgment seem best calculated to advance in every way the efficiency of the library.

(b) Other committees may be appointed as requirements may need.

ARTICLE VI.-ELECTIONS.

The officers shall be nominated by the voting members of the school, and elected by the Church.

ARTICLE VII.—DUTIES OF OFFICERS.

(a) The Superintendent shall conduct the general exercises, preside at business meetings, classify scholars, and by all means in his power, both in school and out, labor to promote its best interests.

(b) The Secretary shall keep a faithful record of membership, attendance, contributions, and business meetings of the school, and report weekly, monthly, quarterly, and annually, as may be required.

(c) The Treasurer shall receive the funds of the school for its expenses and for charitable purposes, and shall make a detailed report annually.

(d) The Librarian shall have the care of the Bible School library, and shall distribute and gather the library books.

(e) The Executive Committee shall appoint and remove teachers, select and purchase lesson helps, and other literature for the school, attend to its business, disburse its charities, and in every way possible provide for its efficiency and welfare.

ART. VIII.-DUTIES OF TEACHERS.

It shall be the duty of the teachers to make thorough preparation for teaching the lesson; to attend the teachers' meetings; to be punctual and regular at the sessions of the school; to keep order in their classes; to strive to win the affection and hold the attention of the scholars; to pray for, and if possible with, the scholars; to visit them at their homes, especially when they are sick or have been absent, and by all proper means to try and secure the object for which this school was organized.

ART. IX.—CLASSIFICATION.

This Bible School shall be divided so far as practicable into Primary, Junior, Intermediate and Senior departments. There shall be organized Normal and Home Departments, when in the judgment of the Executive Committee it shall seem best.

ART. X.-AMENDMENTS.

This Constitution may be amended at any regular session of the school by a vote of three fourths of the voting members, provided that notice of the proposed amendment has been given at the preceding session, and provided such amendment is first approved by the church with which the school is connected.

The Young People's Society of Christian Endeavor.

OBJECT:—"To promote an earnest Christian life among our members, to increase their mutual acquaintance, and to make them more useful in the service of God."

The regular meetings of the Endeavor Society are held at 7:30 o'clock Sunday evenings, except the consecration meeting, which is held at 5 o'clock the first Sunday of each month. The committee work of the Endeavor Society has been the greatest resource of the church for the development of new workers. Many who began with doing little things on the committees of the Endeavor Society are now among the most prominent and useful workers in the church.

To encourage Endeavorers to take up the higher duties of workers in the other departments of the church, and to keep the society distinctively a young people's organization, the plan of Advanced Endeavor embodied in the Amendment to the Constitution, printed below, was adopted in the fall of 1898. It is working well, and gives promise of still greater success in the future.

ADVANCED ENDEAVOR.

AMENDMENT-ARTICLE II.

SECTION I. MEMBERS.

Active members of the Society, who are also members of the Church, and active in other departments of church work, may, on recommendation of

the Pastor and Lookout Committee, be promoted to the rank of Advanced Endeavorers. Only those may be thus promoted who are willing to take up, with the thoroughness and heartiness of Christian Endeavor, all church work that appeals to them for service.

SECTION 2. PLEDGE.

Advanced Endeavorers shall take the following pledge:

(The active member's pledge with "in the regular midweek service of the church," substituted for "in every Christian Endeavor prayer meeting.")

SECTION 3. OBJECT.

The object of Advanced Endeavor is to bring workers who have been trained in the Endeavor Society into the other branches of church work, and at the same time to furnish better training for the younger Endeavorers. The goal of Advanced Endeavor is fitness for the duties and responsibilities of all church officers, and ability to perform the highest services for Christ and the Church.

SECTION 4. DUTIES.

Advanced Endeavorers are excused from attending the Endeavor prayer meetings, except the monthly consecration meeting, from serving on the Endeavor committees, except as advisory members, and from voting and holding office in the society. They shall serve the church as loyal workers in all its activities, as members of its committees, church visitors, pastor's assistants, teachers and officers in the Bible School, and shall be especially responsible for the interest and effectiveness of the church prayer meeting. They shall watch over and promote the interests of the Endeavor Societies of the

church in every way, and definitely as provided in the next section.

SECTION 5. ADVISORY COUNCIL.

At the semi-annual election, advisory members for each of the principal committees of the Society shall be chosen from among the Advanced Endeavorers. It shall be the duty of these advisory members to meet with their respective committees, and give advice and counsel concerning the committee's work. Together they shall form an Advisory Council, whose duties shall be (1) to give advice and counsel to the officers and committees of the Society in all matters where it is desired, meeting with the Cabinet for this purpose when requested to do so; (2) to perform like service for the officers and committees of the Junior Society; and (3) to have charge of all the special interests of Advanced Endeavor. For this last purpose they may organize by choosing a chairman and a secretary from their own number

The Cabinet of the Endeavor Society consists of the officers and chairmen of the various committees.



The Junior Endeavor Society.

This branch of the work was organized in 1894, and has grown steadily in numbers, interest and usefulness. A number have joined the church from this society. Its meetings are held at 5 o'clock Sunday afternoon under the leadership of Mr. S. T. Noble.

The Children's Mission Band did good work for several years. Of late it has seemed best to combine this work with that of the Junior Endeavor Society.

A sewing class of little girls was started by Miss Alice Bullard in 1898, and is proving very successful.

All children's work, except that done by the Bible School, is under the supervision of the church committee on children's work, of which Mr. S. T. Noble is chairman.

Societies of Women.

THE WOMAN'S MISSIONARY SOCIETY.

This Society was formed October 15, 1874, and is thus fourteen years older than the church. It orignally included ladies from the Vernon and Talcottville churches, as well as from both the First and Second Churches of Rockville. It has had but one President. Mrs. Ellen F. Hyde, whose husband was pastor of the Second Church when the society was formed, and but two Secretaries, Mrs. Laura H. Hall and Mrs. A. P. Dickinson. Its monthly meetings have been a constant source of missionary inspiration. The present membership is 65. Perhaps it is the only organization in the church that spends no money on itself. Its contributions for missionary objects up to the time of the formation of the Union Church amounted to \$1,689; since that time \$1,971; a total of \$3,660.

THE LADIES' AID SOCIETY.

This Society was formed November 19, 1888. Its object is to cultivate the social side of church life, and "to aid in any good work." Monthly suppers are given during the winter, and the money received from this source and occasional entertainments has been used for several good works, much of it having gone to reduce the debt of the Ecclesiastical Society. This Society has usually sent a missionary box each year about Thanksgiving time,—the boxes being filled with clothing and other necessaries, mostly new, and worth from \$50 to \$75.

KING'S DAUGHTERS.

The Union Circle of King's Daughters was formed early in the history of the church, and has done much in a quiet way to "develop spiritual life and to stimulate Christian activity." A second circle, composed of young girls, was formed in 1890, but has not continued.

The Men's Union.

In February, 1898, the pastor addressed a circular letter to the men of the congregation, asking a series of questions concerning the relation of men to the church. The answers to these questions, which came from men of all classes and ways of thinking. formed the subject of two sermons. The matter was then taken up by the church, a committee appointed to consider the problem, and as a result of their recommendation, the Men's Union was formed. It has for its object the two-fold purpose of increasing the interest in the Sunday evening services of the church and of promoting the spirit of fellowship and brotherhood among the men of the congregation. Since its organization there has been a marked change in the character and effectiveness of the Sunday evening service, and the Union has done

some splendid things in a social way. In May a supper was given, at which Company C, First Connecticut Volunteers, who were to leave next day for the Spanish war, were the guests of the Union. More than three hundred ate of this supper. Later, the Union has given the people of the town the opportunity of hearing three splendid lectures and one concert without any admission fee. The annual banquet of the Union was held March 21, with seventy-five men at the tables.

The Union chose for its first president, F. T. Maxwell; for the second, D. F. Burritt; for the third, E. L. Heath.

The Maxwell free Reading Rooms.

At a special meeting of the Ecclesiastical Society held February 12, 1892, the following resolutions were adopted:

That the Union Ecclesiastical Society highly appreciates and gratefully accepts the generous legacy of five thousand dollars from the late George Maxwell, deceased, for the establishment and maintenance of a Reading Room and Library connected with the Union Congregational Church, and this Society hereby authorizes the use for the purposes of said Reading Room and Library, of the two connecting rooms in the basement of the church nearest the square tower on Union street, together with the vestibule connected therewith.

That five persons, viz: Dwight Loomis, Francis T. Maxwell, George Sykes, William H. Prescott

and J. C. Hammond, Jr., be and hereby are appointed trustees to serve without compensation, whose duties shall be to receive, take care of, invest and reinvest from time to time as they may deem most secure, said fund, and to collect the interest accruing therefrom and expend it for the purpose of furnishing for said Reading Room and Library such newspapers, periodicals, magazines and books as may be selected for that purpose by a Literature Committee consisting of five persons to be appointed by the church, which appointment is hereby expressly authorized by the Society.

That said fund shall be known and called by the name of the "George Maxwell Fund."

That the use of said Reading Room and Library shall be free for all the people of Rockville of every denomination, under such regulations as the Literature Committee may prescribe.

Two other resolutions expressed the thanks of the Society to the Maxwell family for furnishing the rooms, and providing for the furnishing of the vestibule.

Two weeks later the church appointed the Literature Committee. The room were opened March 3d, 1892.

The only change in the Board of Trustees was the resignation of Judge Loomis on his removal from town, and the appointment of Judge B. H. Bill in his place.

The present Literature Committee consists of the Pastor, William Maxwell, J. Alice Maxwell, Mrs. B. H. Bill and S. Tracy Noble.

The average daily attendance at the Reading Rooms in 1898 was 81; the total attendance for the year about 25,000.


Libraries.

THE MISSIONARY LIBRARY, consisting of about 21 volumes of the latest and best missionary biographies, descriptions, travels, etc.


THE TEACHERS' LIBRARY, consisting at present of 41 volumes of books selected and set apart for the special use of the teachers in the Bible School. To this number the Bible School will make annual additions.

THE BIBLE SCHOOL LIBRARY, in the room adjoining the Reading Rooms, consists of about 800 volumes for the Junior and Senior Departments, and about 330 for the Primary. The Bible School Library Fund, consisting of two legacies of \$100 each from Mrs. Henrietta Bodfish and Mrs. Harriet J. Thompson, is kept on deposit in the savings bank, and the interest used by the Library Committee for the purchase of new books. This fund amounts now to \$222.30. This committee consists of S. T. Noble, D. F. Burritt and Mrs. D. F. Andrews.

I. MEMBERSHIP.

Bible School.—Enrollment, main school, 562; home department, 49; total, 611. Largest attendance, 480; smallest, 98; average, 366.

Ecclesiastical Society.-\$5,162.

Benevolence.-Foreign Missions, \$6%; Home Missions, \$256; Education, \$191; Church Building Society, \$34; American Missionary Association, \$365; Cong. S. S. and P. Society, \$48; Ministers' Fund, \$78; other objects, \$292; total, \$1,960.

Home Expenses.—Deducting the amount given for outside benevolences from the total raised, we have \$7,446, as the amount expended in our local work.

NOTES.—The pastor attended 32 funerals, and solemnized 20 marriages. He reports 542 calls; the deaconesses 421, report incomplete; the Bible School Visitor, 700; total, 1663.

The average daily attendance at the Reading Rooms has been over 66. The Ladies' Aid Society sent three boxes this year, one of reading matter and two of clothing, at a cost of \$181. The Woman's Missionary Society gave \$125 as usual to maintain a scholarship in the American College for girls at Constantinople. The Forward Movement Conference received a gift of \$250. The Endeavorers paid for a pew in the new chapel at Tougaloo. The Bible School has contributed more for benevolence than for a number of years.

Besides its regular work the choir has given five special musical services, assisted by singers from out of town. The position of organist and choirmaster, made vacant by the death of Mr. G. A. Mietzke, Nov 26, was filled by the choice of Mr. A. E. Waite.
